PREFACE.

When Alfred Cave published his Introduction to Theology in 1886, he felt justified in making the statement that "general bibliography is not so advanced as the bibliography of theology." If that was true then, now nearly half a century ago, then, bibliographically speaking, the "queen of sciences" has indeed fallen far, for, of all the divisions of knowledge, theology is, in this particular aspect, the most neglected.

Some time ago the writer of this preface began compiling a bibliography of the literature of biblical prophecy, published in Great Britian and America, down to the close of the eighteenth century, only to realize, before he had proceeded very far, that he was in great need of a more or less complete list of the bibliographies of theological and biblical literature in general, published during this particular period. He was surprised indeed to discover that such a list had never been compiled, with anything approaching completeness. The following pages are the result of his own effort to supply that need.

The attempt is here made to include all bibliographies of biblical and theological literature that have been separately published in Great Britian and America, from that of Maunsell, in 1595, down to the last work of this kind that the compiler has found, published in 1931. The list does not include bibliographies of church history. A comprehensive bibliography of church history, in English, has been a desideratum for many years: the need has been partly met by a work that has just appeared, A Bibliographical Guide to the History of Christianity, edited by S. J. Case. (Chicago. 1931. pp. xi. 265.) Christian missions, religious education, or non-Christian religions, but confines itself with more or less strictness to the works indicated in the title, "biblical and theological literature." In other words, the fundamental purpose of this particular list is to record those bibliographies which cover, principally, the literature devoted to the history and interpretation of the Scriptures. For this reason, the important lists of editions of the Bible that have been published in England and America are included. The catalogues of the theological seminaries in Great Britian and this country are also included. As the result of an extended correspondence, it is believed that no theological institution in the United iv Preface

States or Canada, now in existence, has ever (separately) published a catalogue of its library that is not found in the following pages.

The necessity of limiting the titles in such a work as this to bibliographies that have been separately published need not be explained to any who have seriously attempted any similar work. To have listed all the bibliographies of biblical and theological literature would have necessitated including practically every important publication in these fields, at least almost every theological work published during the last fifty years, together with literally hundreds of articles appearing in biblical encyclopaedias, and many others scattered about in periodicals. A few exceptions have been made. Some books, published in the early part of the nineteenth century, mainly theological, but carrying bibliographic lists, have been included, because of the importance of the lists at the time they appeared, and the influence they exerted. A few later titles have also been included, when the bibliography noted was not entirely theological or biblical, but primarily so, as e. g. the Carnegie Library (1908), and Newberry Library (1925) bibliographies of religious literature.

A few exceptions have also been made in the matter of Church history. Such a work as Dupin's History of Ecclesiastical Writers is included, because it is to be considered more a bibliography of the writers of the Church than a Church history. Denominational bibliographies, which are primarily concerned with listing historical material relating to a particular denomination, are not included; when, however, the bibliography attempts to list the publications of the members of that denomination, which is an altogether different matter, the title finds its place in the following pages.

The chronological order has been followed, though here and there exceptions will be noted. Thus, in listing the bibliographies by Sonnenschein, the earliest issue of his Best Books will be found, not under the date of its publication (1887), but, rather, some ten years later, when the theological part of this work was first published separately. Furthermore, unless a book radically changes as it passes through various editions, the title will be found given under the date of its first publication, and all the later editions are enumerated in this place. The Index will permit any one examining the bibliography to immediately find the entry for any work of which he may himself have an edition later than the first, while the placing of all the editions of a single work under one entry will permit him at once to be fully informed concerning its entire

history. The various catalogues of the Library of Andover Theological Seminary, however, are given under their respective dates of publication, as are also those of the British and Foreign Bible Society, and a few others, because of the complete change which these publications underwent in their various revisions.

Particular pains have been taken to make the bibliographic works of Dupin, Marsh, and Horne, more or less complete, because of the difficulty that normally attends any attempt to arrange the various volumes of these titles in correct order, and because of the repeated inaccuracies that are to be found in other lists of these works. All the volumes of Horne's famous *Introduction* are not bibliographic: but the bibliographic part can best be understood as the entire work is brought under consideration. This is also true of the writings of Marsh.

A great deal of labor has gone into the brief biographical items that follow the authors' names. Much of this data has been secured by extensive correspondence, and some of it will not be found in any other publication, or even in the card catalogues of our great libraries.

No one could be more keenly aware of the shortcomings of this list than the one whose pleasure it has been to compile it. He particularly regrets the following omissions: (1) the earlier catalogues of the Williams' Library, in London; (2) many of the publications of William Cave: (3) the first editions of some works, of which the compiler has been able to find no trace whatever, e. g., the first edition (1899) of the Catalogue of the Anglican Library of the Society for the Home Study of Holy Scripture and Church History; (4) many of the catalogues of London and American booksellers, specializing in theological literature. A complete list of the catalogues of theological booksellers will probably never be published; in fact, one questions if it could even be compiled. One London firm, of which the writer has knowledge, has just issued its 436th catalogue of theological books for sale. Even if such a catalogue were published, no library in the world, nor any ten of them, could show an enquiring student more than a small fraction of the titles such a bibliography would enumerate. The following pages contain the titles of only some of the larger catalogues of this nature, and those more easily accessible in the larger theological libraries of our country. Auction catalogues of private libraries, catalogues of Bibles placed on exhibition in various institutions, and the vi Preface

catalogues of the publishers of theological literature, are not included in this list.

It is impossible to even name all those who have so generously given of their time and thought in the compilation of this work. From one end of the country to the other the greatest interest and courtesy has been continually shown by librarians and theological professors. Yet I cannot let this work appear without acknowledging a few of the heavier obligations which have been incurred. Miss M. M. Pillsbury, Librarian of the General Theological Library, Boston, very kindly had prepared a complete list of all the reading-lists which that Library has published, numbering some seventy-five items. The Rev. Wyllys Reed, D.D., Librarian of the Maryland Diocesan Library, located at Johns Hopkins University, Baltimore, has been exceedingly kind on many occasions,—even in the hottest weather. Miss Mary H. Eastman, Reference Librarian in the Wilmington Institute Library, Wilmington, Delaware, has been most helpful in matters of biographical information. Like many other workers in the field of theological literature, I am deeply indebted to Dr. Frank Grant Lewis, Librarian of the Bucknell Library, Crozer Theological Seminary, Chester, Pa., for the hours of invaluable assistance he so graciously gave me while searching for certain material at Crozer. The Rev. William Boyd Sheddan, Librarian at the Theological Seminary at Princeton, New Jersey, has frequently placed the resources of that great library at my disposal, in a most generous No librarian could possibly answer correspondence more helpfully than Miss Agnes D. MacDonald, Librarian of Western Theological Seminary, Pittsburgh, Pa. The Rev. Abdel Ross Wertz, Ph.D., Librarian of the Lutheran Theological Seminary, at Gettysburg, Pa., has frequently and freely given most valuable and minute information concerning difficult matters in literature of Lutheran bibliography. Professor Rayner W. Kelsey, Ph.D., Professor of History, and Curator of the Quaker Collection, at Haverford College, Haverford, Pa., has been equally helpful in matters of Quaker bibliography. There are many others, who have also sent copies of bibliographies they have published, or that were published by institutions with which they are connected.

My indebtedness to John Graves Barrow, PhD., of Yale University, is more than can be expressed. When the manuscript of this bibliography was practically complete (it was thought), and the first few pages had been given to the printer, the compiler's

attention was called to Dr. Barrow's doctoral dissertation, in manuscript, "A Bibliography of Bibliographies in Religion, with a Critical Study of Bibliographies dealing with American Protestant Missions to Foreign Lands." Dr. Barrow met the writer in New York City within twenty-four hours after this information was received, and, laving the entire manuscript on the table, comprising some two thousand titles, which he had gathered in all the principal libraries of Western Europe, gave him the most magnanimous invitation—"Take anything you can use." The titles which appear in the following pages, that were entirely taken from Dr. Barrow's manuscript (though many of them have since been personally examined), are as follows: Boswell, 1743; Owen, 1776; Glover, 1840; Copinger, 1889; Sigmund, 1909; and Hudson, 1923. addition, the following catalogues of British institutions were taken: Edinburgh, 1787; Aberdeen, 1790; Edinburgh, 1839; Peterborough, 1842; Glasgow, 1863; Edinburgh, 1863; London, 1871; Hastings, 1894; London, 1904; and, Cambridge, 1916. The compiler is indebted to Dr. Barrow for the titles of the (London) Student Christian Movement. Important details for other titles which were already in this list were likewise taken from Dr. Barrow's pages, perhaps in two score different entries.

How many titles that are to be found in the following pages are not vet in Dr. Barrow's more comprehensive work has not vet been determined; twenty would perhaps be a maximum. His list includes works in all the principal European languages, and covers church history, missions, etc. When the titles here enumerated that are not yet in his catalogue are incorportated, his will of course be the final work of authority. He most graciously urged that this smaller list, however, be published, as the date when his would appear was very uncertain. In three particulars only can the compiler of this bibliography hope that it may have some permanent value, and that is in its notations, its biographical information, and in the exhaustive way in which it has undertaken to list such works as those of Horne and Marsh. It should be added that Dr. Barrow has entered all the relevant works of William Cave, and all the catalogues of Dr. Williams' Library. Much of the value which this present publication may have is due to the undeserved generosity of one whom I am honoured in calling a friend indeed.

The author need hardly add that he is not one trained in the details of the science of bibliography. He has not even asked an expert in this field to carefully scrutinize these pages, as no doubt

he should have done. The mistakes and blemishes are all the compiler's only. No one will more appreciate corrections, additions, and suggestions, than he, should those who examine this bibliography choose to record them.

ANDREW MUANSELL (d. 1595). London bookseller.

The First Part of the Catalogue of English Printed Bookes: which concerneth such matters of Diuinitie, as have bin either written on our owne Tongue, or translated out of anie other language: etc. London. 1595. fol. 123 pp.

Maunsell's work was based upon the previous labors of John Leland (1506-1552)—Collectanes, in four MS. volumes, published some years later by Hearne, Oxford, 1715, in 6 vols.; and, upon the work of John Bale (1495-1563)—Illustrium Majoris Britannias Scriptorum Summarium in quinque centurias divisum. 1548. It was ultimately superseded by William London's (fl. 1658) Catalogue of the most vendible books in England. London. 1658. Supplement. 1660.

In the first part of Maunsell's Catalogus are the titles of 2,639 books and sermons; in the second part, published the same year, 27 pp., are 321 additional titles, concerning "the sciences mathematicall and also phisick and surgerie." "It affords the titles of many works, and records the names of various authors, long since lost or forgotten." Lowndes.

JOHN GEE (1536-1639). Clergyman of the Church of England.

The Foot out of the Snare, with a detection of sundry late practices and impostures of the priests, and Iesuits in England; whereunto is added a Catalogue of Popish Bookes lately dispersed in our Kingdome, the Printers, Binders, Sellers, and Dispensers of such Bookes, Romish Priests, and Iesuits resident about London, Popish Physicians practising about London. This volume was printed four times the same year, because, according to Wood's Athenae Oxoniensis, "all copies, or most of them, were bought up by Roman Catholics."

The Catalogue itself, which covers ten unnumbered pages, has the following title: "A Catalogue or Note of such English bookes (to the knowledge of which I could come) as have been printed, reprinted, or dispersed by the Priests and their Agents in this Kingdom, within these two years last past, or thereabouts."

An Appendix to the above was published in London the same year, with the title—"New Shreds of the Old Snare, containing the Apparitions of two new female ghosts, etc."

JEAN (JOHN) VERNEUIL (1583?-1647). Sub-Librarian of the Bodleian Library.

Madan, ut supra, p. 202, says that the second edition was double the size of the first, and adds, "Nearly all the books referred to in the work have their Bodliean references affixed, the arrangement being in the order of the books of the Bible, the Apocrypha being excluded. The fact that some of the books were not in the library 'stirred up some well-wishers . . . who deprived themselves to furnish this Place with some Books that were wanting,' among whom was Robert Burton."

JOHN WILKINS (1614-1672). Bishop of Chester.

Ecclesiastes, Or, a discourse concerning the Gift of Preaching, as it falls under the Rules of Art. Showing the most proper Rules and Directions, for Method, Invention, Books, Expression, whereby a Minister may be furnished with such abilities as may make him a Workman that needs not to be ashamed. Undoubtedly Cave was a very credulous writer, and incorporated in his pages the judgments of Roman Catholics without much criticism. Jortin called him 'the whitewasher of the ancients.' Nevertheless, however dubitable his biography and suspect his criticism, his book remains today the great guide to manuscript lore prior to the invention of printing. Cave is for MSS, what Winer is for printed books. . . . But the chronological order passed out of fashion with Cave, and reasonably. So long as the Church was undivided, and so long as the number of writers was, under the influence of Rome, comparatively small, treatment by centuries was instructive as well as feasible; but when the Reformation gave rise to many sects and innumerable writers, it was scarcely possible and certainly undesirable to proceed any longer on the secular method. In the multiplicity of books the chronological order has given place to the order of subjects." William Cave: An Introduction to Theology. Edinburgh. 1886. p. 98.

The above quotation from the *Life of Adam Clarke* makes impossible the year 1830 (as given in McClintock and Strong, and followed by many since) as the one in which J. B. B. Clarke's supplementary volume appeared.

HERBERT MARSH (1757-1839). Bishop of Peterborough.

Darling's work is, for the literature of theology as far as the middle of the nineteenth century, the most exhaustive work of its kind in the English language. The only bibliographies that can even compare with it, of later publication, are those of Hurst (1883,

1895), and the last edition of Sonnenschein (1910). A new edition of Darling, on the same comprehensive scale, bringing it up to date in every department of theological literature, would be of tremendous value today, in the confusion of thousands of volumes that are pouring from the presses of Great Britian and America.

The following words of Darling himself, are worth recording: "The greater part of the present work is the result of a careful inspection, often leaf by leaf, of the books contained in the Metropolitan Library, founded by the compiler in January, 1840, in order to supply a want greatly felt for an institution, where, for a small annual subscription, members could obtain at their own residence the use of books of a superior order, ancient as well as modern, specially in Theology, and in the various languages . . . Other books, not yet in the Library, are added, in order that it may have that completeness which may render it as a useful guide in all libraries. . . The name of each author is accompanied by a short, but as comprehensive as possible, biographical and characteristic notice, so far as can be ascertained from authentic sources. The notice of each author is followed by the full titles of all or the most important of his works, with critical notices where necessary. The variations of editions are specified, and those that are considered the best are indicated. No tables of contents have been followed, but a careful examination has been made in order to exhibit the most essential topics of every book, and give a full analytical view of the subjects on which each author has written. The books contained in the collected publications of early and middle-age writers, are enumerated at length. The plan embraces objects which have never yet been attempted on a complete scale in any bibliographical work."

The Did. of Nat. Biog. says this work was, next to Watt and Lowndes, "the most important bibliographical work ever produced in England."

"This list is compiled for the use of ministers of average attainments, and the brief reviews are written from that standpoint. . . In almost every case the books have been actually examined by myself, and my opinion, whatever it may be worth, is an original one. Numbers of volumes have been left out because they were not easily procurable, or were judged to be worthless, although some of both of these classes have been admitted as specimens, or as warnings. Latin authors are not inserted, because few can procure them, and fewer still can read them with ease. It is to be specially noted, that in no case do we endorse all that any author has written in his commentary. We could not read the works through, it would have needed a Methuselah to do that, nor have we thought it needful to omit a book because it contains a measure of errors provided it is useful in its own way; for this catalogue is for thoughtful, discerning men and not for children.

"The writers on the Prophetical Books have completely mastered us, and after almost completing a full list, we could not in our conscience believe that a tithe of them would yield anything to the student but bewilderment, and therefore we reduce the number to small dimensions."

The work progressed satisfactorily . . . but the material became unwieldly, and after two years of such labor as could be bestowed upon it, the completion seemed farther in the future than at the outset. As one grows older, however, and his duties bring him into closer relationship with immediate needs, he is likely to compress his plans, and aim at a more direct result. I reached a point where it seemed best to sacrifice a cherished plan to a public want, and, instead of preparing a bibliographical work in several large volumes, to confine myself to a more compact book, which should be adapted to the British and American public, and contain mainly the titles of books procurable in the market of this country and Great Britian. The most of the preparation for the larger, and now discarded, work, has been of little service in the preparation of this more practical one." Preface.

Under each book the plays are again arranged under incidents in the order given in each book. . . .
